Conditions of Acceptance

- 1. All soil samples must be contained in strong plastic bags indelibly labelled and sealed.
- 2. The area to be sampled should not exceed 8 hectares (20 acres).
- 3. Areas of land differing in soil type, previous cropping, applications of manure, fertiliser or lime, should be sampled separately.
- 4. Do not sample within 3 metres of a headland or dyke.
- 5. Samples should be taken to a depth of 15 cm for arable and field vegetable systems and 7.5 cm for long term grassland.
- 6. A sample should consist of 25 individual sub-samples taken from a uniform area. Additional samples will be required where there is mixed cropping or visual changes in soil type.
- 7. The location of the 25 sub-samples must be selected systematically with an even distribution over the whole area. This may be achieved by following the pattern of a letter 'W'.
- 8. All samples submitted must conform to the criteria set out in conditions 1 to 7 above and must be accompanied by a fully completed field form.
- 9. All testing undertaken by Anglian Soil Analysis Limited will be carried out in accordance with the Anglian Soil Analysis Limited testing protocol.
- 10. Whilst every precaution has been taken to ensure the accuracy of testing undertaken by Anglian Soil Analysis Limited no liability can be accepted for any loss or damage arising whether or not there has been any negligence in the sampling, the analysis or preparation of the test results.
