## **PCN FIELD FORM**

### **Conditions of Acceptance**

1. All soil samples must be contained in strong plastic bags indelibly labelled and sealed.
2. A PCN sample must not be taken from an area larger than 4 hectares (10 acres). If a field is larger than this it must be sub-divided.
3. Sub-samples of soil ('cores') should be taken using a T handled tool with a blade of half-tubular section at least 20 cm long.
4. A sample should consist of 40 individual sub-samples taken from a uniform area. Additional samples will be required where there is mixed cropping or visual changes in soil type.
5. The location of the 40 sub-samples must be selected systematically with an even distribution over the whole area. This may be achieved by following the pattern of a letter 'W'.
6. Each PCN sample must be at least 1½ kilogrammes in weight or two kilogrammes where additional analyses are required.
7. All samples submitted must conform to the criteria set out in conditions 1 to 6 above and must be accompanied by a fully completed field form.
8. All testing undertaken by Anglian Soil Analysis Limited will be carried out in accordance with the Anglian Soil Analysis Limited testing protocol.
9. Whilst every precaution has been taken to ensure the accuracy of testing undertaken by Anglian Soil Analysis Limited no liability can be accepted for any loss or damage arising whether or not there has been any negligence in the sampling, the analysis or preparation of the test results.
10. All analyses and subsequent results undertaken by Anglian Soil Analysis Limited are given on the understanding that the sampler has read and abided by the conditions 1 to 6 above.
11. Responsibility for the interpretation of these results rests with the client. No liability (whether express or implied) is accepted on the part of Anglian Soil Analysis Limited.
